General Rules and Regulations For Cairo International Fair

- **Engineering Rules and Requirements:**
- The maximum height allowed for indoor exhibition area is 6 meters
It is mandatory to submit an original and three copies of the engineering drawings to the Engineering & Security Departments for approval at least seven days before handing over the location. These drawings must clearly indicate all dimensions (floor plans – facades – sections – corridors – escape routes – locations of fire cabinets – power distribution panel/two phase and three phase – water supply distribution board – advertising signs and its installation method). In addition to stating the materials used in constructing the booth/decor
- EECA reserves the right to make any necessary modifications to all engineering drawings for the sake of work. Construction will be permitted subject to the approval of the engineering drawing
- No fixtures or attachments are permitted on the walls, columns, or floors within the covered halls
- The exhibitor is obligated to dismantle and remove all decorations and exhibits, and to vacate the space immediately upon the end of the exhibition, within a maximum of three(3)days, delivering the site in the same condition as it was received
- Compliance with the technical specifications and standards for electrical connections used in the exhibition is mandatory and should be in accordance with the applicable codes. All engineering drawings must be approved by EECA's Engineering Department prior to execution
- Pathways must be provided in front of fire hose cabinets, or alternatively doors measuring 80 cm in width and 2 m in height must be installed, with clear passages maintained within the booths. No obstructions shall be placed in front of these cabinets
- No obstacles are permitted in front of emergency exits, loading doors, hall entrances, air-conditioning vents, or return air ducts. Pathways of no less than 2 meters must be provided in front of these areas, with an adequate number of directional signs clearly indicating them. Trained personnel must be available to guide attendees towards the emergency exits and ensure the prompt evacuation of the premises

Regulations of Civil Defense, Safety and Occupational Health For Cairo International Fair2026 Indoor Display

We kindly request you to comply with all requirements related to civil defense, safety and occupational health. These conditions applies to every organizer, exhibitor, or booth inside the halls (including indoor displays), effective from the time of entry to EECA grounds until departure and clearance of all exhibits and decorations from the exhibition

- 1) Submission of engineering drawings with the security file in a sufficient time before the coordination meeting to obtain approval from the Civil Defense Department. These drawings must clearly indicate escape routes, pathways and fire
- 2) Providing access pathways in front of fire boxes or installing doors with dimensions of 110 cm width × 2 m height, and Providing Clear Walkways within the pavilions without any obstructions
- 3) It is prohibited to put any obstacles in front of emergency exits, loading doors, and hall meters must be maintained in front of these areas, with an 2 entrances. A minimum of adequate number of signs and trained personnel available to guide attendees to the emergency exits and quick evacuations
- 4) It is strictly prohibited to store or place any waste behind the booths and have any flammable materials within the exhibition or the pavilion
- 5) The use of electric saws, grinders, welding machines, or any equipment that produces sawdust and sparks are strictly forbidden inside the exhibition halls
- 6) Smoking inside the halls and closed areas is strictly prohibited
- 7) The use of tea and coffee boilers, electric kettles, heaters, gas cylinders, or any similar heating appliances) thermal devices) is not allowed
- 8) Carpets and any fabrics used in decorations must be treated against fire hazards (fire retardant). An accredited certificate (from Chemistry Administration of the Ministry of Trade and Industry or National Research Center...) must be provided. Tests will be conducted before entry. A declaration and commitment must be submitted confirming that the quantity of carpet used matches the approved sample
- 9) All electrical connections used in the exhibition must adhere to technical specifications and standards according to the electrical code. Floor plans and engineering drawings must be approved by EECA Engineering Department before construction
- 10) No advertising boards or metal structures such as metal truss and others may be installed without supervision from the Central Administration of Engineering Affairs
- 11) All electrical devices found within the pavilions must be switched off. If an exhibitor request to operate equipment for a period longer than the exhibition closing date, written approval must be approved by EECA Electricity Department. Each exhibitor is responsible for his belongings during the set up and until evacuation

- 12) All laborers must be at least 18 years old in accordance with laws. Each participating company shall be fully responsible for the deeds and acts of its workers. Every exhibitor, organizer, or private pavilion must take all defensive measures to protect its workers, which guarantees protection for them from exposure to risks, including occupational safety and health, provided that it is applied from the beginning of the setup until the evacuation
- 13) Participating companies bear full civil and legal liability for any damages to individuals, facilities, visitors, or others resulting from violations of the above requirements or any related laws, rules, or regulations. The company will be solely responsible for these violations and will bear full compensation without any liability on EECA
- 14) Financial penalties shall be imposed on the organizing company, exhibitors, or participants in case of violation of civil protection, safety, and occupational health requirements, in accordance with EECA regulations. Fines shall be enforced, and the violation removed. Repeated violations will result in doubling of the fine

Regulations of civil Defense, Safety and Occupational Health For Cairo International2026

We kindly request you to comply with all requirements related to civil defense, safety and occupational health. These conditions applies to every organizer, exhibitor, or booth inside the halls (including outdoor displays), effective from the time of entry to EECA grounds until departure and clearance of all exhibits and decorations from the exhibition

- 1) Submit the floor plans of the exhibition in a sufficient time before the coordination meeting to obtain approval from the Central Security Department. These drawings must clearly indicate emergency exits, escape routes, and pathways, ensuring escape corridors are not less than 2 meters wide, while identifying the locations of fire hose cabinets with clear pathways left in front of them. Adequate directional signs must be intalled to indicate exits and ensure prompt evacuation
- 2) Do not place any obstuctions in front of fire hose cabinets. Adequate longitudinal and transverse pathways must be maintained between tents
- 3) No tent shall be admitted without submission of a certificate of origin plus a recent certificate from an accredited authority (e.g., Chemistry Authority) confirming it is frie retardant. Tests will be conducted prior to entry . A declaration and undertaking must also be submiteed confirming that the amount of leather used in tents matches the approved sample
- 4) Carpets and any fabrics used in decorations must be treated against fire hazards (fire retardant). An accredited certificate (from Chemistry Authority or National Research Center...) must be submitted that the quantity of carpet used in tents matches the approved sample
- 5) Provide a sufficient number of functional fire extinguishers suitable for the rented space These must be placed in visible, easily accessible locations and operated only by trained personnel. Ensure adequate escape routes in every tent, hall, or booth, with clear signage pointing to them
- 6) All electrical connections used in the exhibtion must comply with technical standards and codes. Engineering drawings (Floor plans) must be approved by EECA's Engineering Department prior to construction. No electrical supply may be connected to any tent or booth except under EECA's Electrical Department supervision. Lighting fixtures inside tents must be safe and installed at least 75 cm below the ceiling. Each booth must have an automatic circuit breaker panel, protected by insulation, which disconnects power in case of emergency
- 7) Ensure all electrical equipment in booths is switched off after closing hours. For operation beyond official closing time, prior written approval must be obtained from EECA's Electrical Department, Each exhibitor is reponsible for securing their belongings throughout setup, exhibition days, and dismantling

- 8) The use of tea/coffee heaters, kettles, space heaters, gas cylinders, or similar heating devices is strictly prohibited. The use of open flames in food courts is forbidden. Only electric stoves are allowed , with sufficient fire xtiguishers and adequate quantities of sand buckets for firefighting provided
- 9) Waste materials must not be stored or accumulate. They must be removed immediately from EECA premises to avoid fire hazards. The presence of flammable materials in the exhibition or booths is strictly prohibited
- 10) Smoking is strictly prohibited inside halls, tents, and enclosed areas. Clear (No Smoking) signs must be displayed
- 11) No advertising boards metal structures. or similar installations (such as iron trusses) may be installed except under the supervision of the Central Department for Engineering
- 12) All laborers must be over 18 years of age, in compliance with laws. Each participating company is fully responsible for the conduct and actions of its workers from the setup until the end of dismantling
- 13) Participating companies bear full civil and legal leability for any damages to individuals facilities, visitors, or others resulting from violations of the above requirements or any related laws, rules or regulations. The company will be solely responsible for these violations and will bear full compensation without any liability on EECA
- 14) Financial penalties shall be imposed on the organizing company, exhibitors, or participants in case of violation of civil protection, safety, and occupational health requirements, in accordance with EECA regulations. Fines shall be enforced, and the violation removed. Repeated violations will result in doubling of the fine

Regulations of Civil Defense, Safety and Occupational Health For Cairo International Fair2026

We kindly request that you comply with all requirements related to civil defense, occupational health and safety. These conditions applies to every organizer, exhibitor, booth, or kiosk (in the food court in the outdoor exhibition area) effective from the time of entry to EECA grounds until departure and clearance of all exhibits and decorations from the exhibition. Each participant in the exhibition must adhere to the following:

- 1) Do not place any obstructions in front of fire hose cabinets, and leave longitudinal and transverse passage between kiosks in the food court area
- 2) No tents will be allowed to enter without submitting a certificate of origin + a recent certificate from an accredited authority (such as the Chemical Authority ...) stating that they have been treated against fire hazards. Taking into consideration that fire tests will be conducted on it before entry, along with a declaration and commitment that the leather used in the tents complies with the approved sample
- 3) Carpets or any fabrics used in the decorations must be treated against fire hazards (fire retardant) with a certified certificate provided (from the Chemistry Administration, National Research Center, etc.). Fire tests will be conducted before entry, along with a declaration that the amount of carpet used matches the approved sample
- 4) Each food kiosk and every movable food truck must provide an adequate number of manual fire extinguishers (dry powder + carbon dioxide) that are in good working condition, sufficient for the rented space, and placed in visible and accessible locations, to be used only by trained personnel, while ensuring that there are sufficient escape routes for each area
- 5) All electrical wiring and installations in the exhibition area must comply with technical specifications and standards according to the electrical code. Engineering drawings (floor plans) must be approved by EECA Engineering Department before installation. No electrical source may be connected to any food kiosk or movable food truck except under the supervision of EECA Electrical Department
- 6) Ensure all electrical devices in booths are turned off. If operation is needed beyond official exhibition hours, written approval must be obtained from EECA Electrical Department
- 7) The use of tea/coffee heaters, kettles, heaters, gas cylinders, or any similar items is strictly prohibited, in addition to banning any equipment that cause flames in the food court area. Only electric stoves are allowed. A sufficient number of functioning fire extinguishers and a proper quantity of sand buckets for firefighting purposes must be available
- 8) Strictly prohibited the use or presence of any flammable materials in booths or the exhibition
- 9) Do not store or accumulate waste. It must be immediately removed to designated collection points to prevent any possible fire hazards
- 10) Smoking is strictly prohibited in closed areas, and appropriate signage must be displayed
- 11) Personal protective equipment (masks, gloves, etc.) must be provided and worn by workers in the food court throughout working hours

- 12) If generators are present, civil protection requirements must be met, and enough functioning must be available, along with trained personnel to use (dry powder + CO₂) fire extinguishers them
- 13) No worker under 18 years of age is allowed, in accordance with the law. Each participating company is fully responsible for the actions and behavior of its workers from the beginning of exhibition preparations until evacuation
- 14) Participating companies bear full civil and legal liability for any damages to individuals, facilities, visitors, or others resulting from violations of the above requirements or any related laws, rules, or regulations. The company will be solely responsible for these violations and will bear full compensation without any liability on EECA
- 15) Financial penalties shall be imposed on the organizing company, exhibitors, or participants in case of violation of civil protection, safety, and occupational health requirements, in accordance with EECA regulations. Fines shall be enforced, and the violation removed. Repeated violations will result in doubling of the fine

Customs Rules for Foreign exhibits at Cairo 2026 International Fair

EGYPT EXPO & CONVENTION AUTHORITY (EECA) located in Nasr city Cairo / Egypt has a limited custom zone at (EECA) in order to finalize customs' procedures on foreign exhibited goods for the purpose of demonstration, re-export or selling, and to facilitate exhibits transportation to (EECA) premises

First : Imported Exhibits:

Temporarily customs released exhibits:

Exhibits which are subjected to temporarily customs release must provide EECA with the following documents

A- Maritime Bill of lading should include:

Identification number: ACID for maritime freight

Shipper: name of foreign participated company or its delegate

shipped to: must be written as follows:

Exhibitor's name (the exhibiting foreign company or pavilion of the exhibiting country- name of exhibition and its premises, Egypt Expo and Convention Authority)

B- Air WayBill should be enlisted in the following order

Shipper: Name of the foreign exhibiting company or its delegate

Shipped to: must be written as follows:

Exhibitor's name (the exhibiting foreign company or pavilion of the exhibiting country- name of exhibition and its premises, Egypt Expo and Convention Authority)

C- The Invoice of Incoming Exhibits

must be clear and in detail, stating the country of origin

D- Certificate of Origin: imported exhibits should be attached with a certificate of origin endorsed by concerned authorities in order to be released from customs

E- Fees:

EECA's Commercial Department will issue the customs letter according to the following

EGP 4000 for non-registered Freight & clearing companies

EGP 2000 for procedures handled by the Exhibitor himsel

N . B:

Kindly include : to the Attention of, the name of the agent or the delegated person or the foreign participant

The exhibits must reach the Egyptian port two weeks prior to the inauguration of the event to guarantee its arrival to EECA in a convenient time especially exhibits that are subject to testing by various authorities

2) Guarantees

A-Official Participation of Countries:

Participated countries should provide an authorized letter from its embassy in Egypt, this letter pledges to settle all customs duty on sold exhibits that will not be re-exported, enclosed by a list of companies exhibiting within the official participation of the country

B-Individual Participation of Foreign companies:

Participant foreign company provides the Customs office With either cash payment or present a letter of guarantee valid for six months From one of the accredited Egyptian banks to facilitate the following procedures

- Transportation of exhibits from port to EECA and back to be re-exported
- Full payment of taxes and customs for exhibits that would not be subjected to re-exportation

3) Foreign exhibits subjected to direct release from customs (samples – modules – media materials used by companies or individuals)

- People in charge of releasing exhibits form customs:
Registered (importers – agents - Factories – exporters laboratories)
Commercial samples, modules, media materials should be examed due to specs and types
- Permission of authorized bodies for samples distribution within exhibition halls (medical, industrial, agricultural, media,..etc)

4) Customs on Alcoholic Drinks and Cigarette

Exhibitor should pay all customs duty on imported Alcoholic drinks and cigarettes. As for drinks consumed by participant within its pavilion, exhibitor should offer a written authorized letter issued by country's embassy and Egyptian Ministry of Foreign Affairs

Second : Egyptian Free Zone Exhibits The participant should apply a request for (EECA) Commercial Affairs Department enclosing following documents

a) Approval of the General Authority for Investment & Free Zones to permit .exhibits transportation to EECA

b) Exhibits Invoices

- The commercial department issues a letter to exhibition customs approving entrance of exhibits to EECA after payment of due amount
- The participant should present the following documents for exhibition customs:
 - Bank Letter of Guarantee with total amount of customs fees as determined by exhibition custom
 - Invoices and the approval of Commercial Affairs Department
 - The exhibitor is entitled to return the exhibits back to the free zone after the event
- Third: Direct Sale to Public (foreign exhibits)
 - 1) Direct sale to public is limited for foreign exhibits in places determined by EECA during the event, exhibitor is entitled to follow the hereby procedures
For direct sale: exhibitor should be granted with an approval from Commercial Department in EECA
 - 2) Retail sale is permitted meanwhile wholesale is totally forbidden
 - 3) Exhibitors who seek license of direct sale for public has to apply a request for commercial affairs department accompanied by exhibits invoices after authorization of exhibition custom administration
 - 4) A copy of the invoice of the Exhibits that will be sold after being approved and stamped by the exhibition customs administration after the customs improvement
 - 5) A Letter from the Organization company stating that the direct sale to the public during the exhibition period shall be permitted, according to the contract between the Authority and organizer
 - 6) Monetary is determined according to total rented space per square meter

\$500 per square meter of total rented areas for exhibitions organized by EECA

- 1) Exhibitor is entitled to pay(% 1)of the permitted quota set by EECA as previously mentioned
- 2) Selling prices are determined due to CIF in addition to customs fees and taxes, taking in consideration that any deduction in invoices value is totally unacceptable
- 3) Exhibition custom administration collect custom fees based on actual sales
- 4) Unsold exhibits should be re-exported due to customs procedures

Fourth: purchase of foreign exhibits:

- Contracting for direct sale during the exhibition is handled between both (exhibitor & buyer) without (EECA'S) slightest responsibility, which by its part facilitate the bargain for both parties applying to the following conditions
- 1) Purchase invoices should be presented in both (Arabic & English) languages
- 2) Authorized letter approved by commercial department to facilitate
- 3) Customs procedures
- Filling application set by commercial department with payment value of (% 1) as purchase fees paid to EECA's financial department

Fifth: Re-exportation of exhibits:

- Exhibits should be re-exported by the end of exhibition within the duration of letter of guarantee validity date (6months) that is presented to exhibition custom
- By the end of validity date (6months) these exhibits will be considered (waste) and custom will have the full authority to handle these exhibits

Sixth : Exhibits Storage after event:

- It's totally prohibited for exhibits to remain inside halls after the event
- After six months of exhibition termination exhibits are confiscated & customs administration has full authority to handle these exhibits

Seventh: List of Prohibited imported Goods:

- Exhibits that has religious essenceAfter six months of exhibition termination
- Offals and limbs of Poultry
- Liver of Poultry
- Two Storks motorcycle non-equipped with oil injection pump
- All Kinds of aspistos materials
- Brake pads made of aspistos material
- Oil treated genetically Tuna
- Insecticides & chemicals
- Sugar cane unless used for scientific research
- Grape plants except fruit
- All kinds of citrus plants and seeds
- Mango fruit & nucleus
- Pears seedlings only seeds are permitted
- All kinds of citrus plants
- Olive seedlings
- Any kind of Agricultural soils, any kind of organic soil material under any name
- All kinds of packets
- Any green parts of plants unless used scientific purposes, except for potatoes-onions rose strawberry seedlings from agriculture seeds tissues and bulbs that helps in increase of plants

- Palm plantations unless resulting from tissue plantation in tubes
- Date palm seedlings or its fruits whether dry or manufactured or green or made from palm litter as palm leaves and palm branches
- Henna and hegaz clover and decoration palm which is considered carrier to eggs disease and sell it to palm mite

Honey

N.B:

In case a country insists to display Prohibited material it should comply with the following condition

- 1) Present all needed written pledged by (country's embassy and pavilion manager) to be in charge of prohibited material after exhibition termination
- 2) Prohibited material should be in limited quantities
Prohibited material should be re-exported or destroyed after exhibition terminated
- 4) Any country which will not be entitled to follow these conditions Should be legally questioned

Eighth: Needed Approvals for foreign exhibits

Due to diversity of exhibits, samples of these exhibits should be subjected to examination by a period of at least (2weeks) prior to event opening ceremony
